Bedales School Admissions Policy

I. General

Bedales School ("the School") is an independent, co-educational boarding and day school for ages 3 to 18 years. The School has approximately 800 students.

Bedales Nursery & Pre-prep, ages 3 - 8 (Nursery - Year 3)

Bedales Prep, ages 8 - 13 (Years 4 - 8)

Bedales Senior School, ages 13 - 18 (Years 9 - 13)

Deciding on the right school for your child is very important. We very much hope that you and your child will make an in-person visit in order to truly experience the uniqueness of Bedales. 2. The Entry Procedure

Bedales is committed to a policy of equal opportunity, offering an academically rigorous, holistic and innovative co-education for 3-18 year olds. Building relationships is key at Bedales, and we work together to ensure that every student leaves us having achieved their academic potential, and discovered their own talents, passions and identities, with a powerful sense of responsibility to others.

Bedales is a selective school, and our approach encourages inquiry, creative thinking and independent learning. We select students who will take initiative and responsibility for themselves, who can work collaboratively with other students and staff, and who can take advantage of the variety of activities and possibilities provided by the School. Religion, ethnicity, sexual orientation and gender identity have no bearing on how we select students, and we will comply with all legislation prohibiting discrimination.

Students with Special Educational Needs and Disabilities may be granted admission, provided that we can make reasonable adjustments that enable us to deliver a Bedales education (see section 9 for further information). Where it is practical to do so given the constraints of our facilities, Bedales will do all that it can to support applicants with physical difficulties.

3. Initial Entry

Initial admission to Bedales School is primarily based on interview with key staff and assessment at the School, as well as references from the candidate's previous school and any specialist reports. From Year 3 upwards, applicants also take our own written assessment, to establish that they meet the expected academic requirements:

- A significant proportion of Bedales students progress to QS Top 100 universities globally, prestigious art colleges and music conservatoires. Prospective students are therefore admitted to the School with this expectation and the potential to follow a suitable A Level pathway. Candidates at 13+ or 14+ must be judged capable of attaining a minimum average grade 6 in GCSE subjects/Bedales Assessed Courses, with higher projections in potential A level subjects
- Sixth Form applicants at 16+ must be judged capable of attaining at least three A level passes at grade C or above. They should also be predicted a minimum average grade 6 at GCSE, including a grade 6 in Maths or English Language.

However, the main focus of all our assessments is on understanding the whole person, and on determining how well they are likely to adapt to the educational experience at Bedales, to contribute to it and to benefit from it.

3.1. Bedales Pre-prep

Early Years

One of the main aims of the Nursery is to prepare children for their later learning at Bedales. This means we give priority for places and sessions to children who are intending to continue their education through the School.

Places in the Nursery are limited, and Bedales Pre-prep will allocate sessions in descending order of priority as follows:

- Those who are going through the School's Pre-prep (into and beyond Reception)
- Those who have older siblings in the Bedales School
- Those who book for 5 full days at the Nursery
- Those who book full days at the Nursery

The suitability of children joining Reception is determined by a day spent at the School.

Years 1- 3

The suitability of children joining from Year 1 to Year 3 is determined by a day spent at the School and an online cognitive assessment (Year 2 & 3 only).

3.2. Bedales Prep

Younger applicants for Bedales Prep (8+, 9+ and 10+) will spend a day in school with time in class with their appropriate year group. This gives the child a chance to become accustomed to life in the School. There are assessments in Maths, English and a 1:1 interview to assess how the child learns and understand their character.

The assessment for entry at 11+ to Bedales Prep is residential, over two days (one night), in January of the year of entry. Alternatively, we also undertake individual assessment days. This gives the child a chance to become accustomed to life in the School. There are assessments in Maths and English plus a 1:1 meeting to understand how the child learns and understand their character. Applicants also have the chance to show their skills in co-curricular activities such as Art, Drama, Sport, Music and Outdoor Work.

3.3. Bedales Senior

The residential two-day assessment for 13+ entry to Bedales takes place in the January two and a half years before the year of entry (e.g. in January 2026 for entry in September 2028). The two-day assessment includes Maths, English and an online ability test together with interviews. Candidates also have the chance to show their skills in co-curricular activities such as Art, Drama, Sport and Outdoor Work. Alternatively, we also undertake individual assessment days.

Admission to the A level Programme is dependent upon the demonstration of an ability to cope with the demands of a challenging course. The normal expectation of potential A level students is a proven academic record and the demonstration of commitment to make a positive contribution to the Bedales community. Sixth Form applicants attend a day of interviews at the School in October of the year before entry which includes A Level subject-based interviews to assess their suitability for Sixth Form study. A verbal reasoning assessment is included, and students may be asked to complete a pre-assessment task in the A level subjects of their choice.

4. Moving up the School

Progression from one year to the next, and from one School to the next, is assumed but is subject to satisfactory behaviour and academic progress. In particular:

- Progression from Bedales Pre-prep to Bedales Prep is assumed subject to satisfactory behaviour and performance. We will monitor their development to ensure that their needs can still be met adequately when they make the transition.
- Progression from Bedales Prep to Bedales Senior is assumed but is subject to satisfactory behaviour and performance.
- Progression from Block 5 to 6.1 (Year 11 to the Sixth Form) is assumed and is normally subject to attaining a minimum average grade 6 at GCSE/Bedales Assessed Courses, with higher grades in A level subjects.

A student's disciplinary record, willingness to cooperate in developing satisfactory habits of learning, participation in extra-curricular activities and relations with other members of the community will be taken into account.

Where it appears that a student's behaviour and/or academic progress may jeopardise their move from one School to the next, or from Block 5 to 6.1, we will inform parents of the possibility and agree with them a plan of action to help the student maximise their potential. Parents will be informed in term 1 of the transition year of any concerns. If, despite the plan of action, the student's behaviour or academic progress remains a concern, we will give notice by the end of the Spring term, in the year when they are due to progress, that they should leave the School. In the case of Block 5 students, we may stipulate a points score in GCSE/BAC as a condition for remaining in the School.

5. Means-tested Bursaries

Parents may apply to be considered for means tested bursary. Such bursaries are awarded based on an external assessment of means and subject to the School having funds available, which are limited. They may be awarded at the time of entry to Bedales Senior (normally at 13+ or 16+) or Bedales Prep at 11+.

6. Scholarships

We may award scholarships to acknowledge candidates of exceptional merit on entry to Bedales Block 3 (Year 9) in Academic, Music, Art, and on progression from Block 5 (Year 11) to the Sixth Form in Academic, Music, Art, Drama, Dance and Sport.

Scholarships take the form of a grant for which applicants apply in consultation with the relevant Head of Department/Director. The maximum financial value of the annual grant is outlined on the School's website together with more information on the awards (at <https://www.bedales.org.uk/home/admissions/scholarships-bursaries>). There is also a Design award for a 6.1 (Year 12) student as they transition into 6.2 (Year 13) involving external mentoring.

At Bedales Prep, Music scholarships and exhibitions can be awarded from 10+ years, involving free tuition on the principal study (instrument or voice). Honorary Academic scholarships may also be awarded from Block 1 (Year 7).

The School's Bursary Policy enables additional support for exceptional students on a means-tested basis.

7. Preferences and limitations

At Bedales School, we may give preference to applicants who have a sibling at the School.

In Bedales Prep and Bedales Senior, we may reserve places for applicants who:

- come from families who cannot afford any or all of the fees with funding from the School's bursary programme and/or an educational trust.
- have a skill that is valuable to the School, such as academic, sport, musical or artistic ability.

Bedales School has limited facilities for those with physical disabilities, but in line with the Special Educational Needs and Disability Act 2001 we make reasonable adjustments as described in section 2. Parents should provide us with full written details of their child's disabilities or special educational needs – the sooner the better, and (for students who are not yet enrolled) no later than registration, so that we can assess the needs and consult parents about possible adjustments.

8. Further information; Terms & Conditions

The Bursar will be pleased to advise on eligibility for financial aid. Overseas applicants will need to comply with our Educational and Legal Guardianship Policy. Once you accept a place at the Bedales School, you accept our standard Terms & Conditions.

9. Special Educational Needs and Disabilities

Bedales School has limited resources to cater for students with mild learning difficulties, eg. Dyslexia, ADHD, high functioning autism. It is in the interests of all concerned they are able to thrive within our environment. If, in exceptional circumstances, the School agrees to accept a student requiring significant support, parents may be asked to pay for additional costs incurred.

Parents of children who have a history of requiring educational support that falls outside of the mainstream classroom are required to declare detailed information regarding their child's specific learning needs.

We ask for transparency from prospective parents in terms of their child's mental health and learning needs. This information should include previous school reports, SENCO reports, and copies of previous Individual Education Plans (IEPs) and/or reports from Educational Psychologists and other professionals, prior to visiting the School. Failure to declare accurately and fully the extent of a child's individual learning needs at the point of application may result subsequently in parents being asked to withdraw their child because the School is unable to meet their learning needs. This is a situation that we are keen to avoid, particularly as it may impact adversely on the child's self-esteem and future learning. If in any doubt, please arrange to speak in confidence to the appropriate Head of School.

10. Complaints

Complaints about our handling of any aspect of the admissions process should be addressed in the first instance to the Head of the relevant School. If the issue is not resolved satisfactorily, it will be subject to the School's Complaints Procedure, a copy of which is available on request.
